Reply :- Please refer to your online RTI application registration no. DOFPD/R/2017/90003 dated 08/03/2017 under RTI Act, 2005 on the above noted subject.

2. In so far as PD.II Section is concerned, it is informed that the Targeted Public Distribution System (TPDS) is operated under the joint responsibility of the Central and the State/Union Territory (UT) Governments. Central Government is responsible for procurement, allocation and transportation of foodgrains upto the designated depots of the Food Corporation of India. The operational responsibilities for allocation of foodgrains within the States/UTs, identification of eligible beneficiaries families, issuance of ration cards to them, distribution of foodgrains to eligible beneficiaries under TPDS and supervision over and monitoring of functioning of Fair Price Shops (FPSs), etc. rest with the concerned State/UT Governments.

3. The information in respect of point no. 1 is already available at official website of this Ministry i.e. www.dfpd.nic.in. However, information in respect of point no. 2 pertains to all State/UT Governments. In addition to this, your application is also being transferred to US(Comp) for providing you the information relevant to them. Therefore, your RTI request is being transferred in terms of section 6(3) of RTI Act, 2005 to all State/UT Governments and US(Comp) for providing you the information relevant to them. You may, therefore, like to approach all State/UT Governments and US(Comp) for further information in the matter. In case reply is not received from the CPIO of the concerned all State/UT Governments and US(Comp) an appeal under RTI may be preferred before the Appellate Authority in the concerned all State/UT Governments and US(Comp) of this Department.



Please refer to your RTI online application registration No. DOFPD/R/2017/90003 dated 8.3.2017 on the subject mentioned above which is received in the Computerisation Cell vide PD.II Section endorsement Lr. No.25/01/2017-PD.II dated 21.03.2017.

2. Computerisation Cell is implementing a Plan scheme on 'End-to-end Computerisation of TPDS Operations' under 12th Five Year Plan (2012-17) on cost sharing basis with the States/UTs. Component-I of the Scheme comprises activities, namely digitization of ration cards/beneficiary and other databases, computerisation of supply-chain management, setting up of transparency portals and grievance redressal mechanisms. National Informatics Centre (NIC) is the technical partner under the scheme. A national transparency portal for TPDS has been developed which can be accessed at <http://pdsportal.nic.in>. Citizens may also access the portal of the respective State/UT Food and Civil Supplies Department through the links provided on the national portal. Digitization of ration cards / beneficiaries' data have been completed in all 36 States & UTs and digitized details of Ration Cards are available on transparency portals of the States/UTs.
