REPORT OF THE LOCAL COMMISSIONER

1. That, pursuant to the Order Dated 25.05.2017 of this Hon'ble Court in W.P.(C) 2161/2017, the Hon'ble Acting Chief Justice and Hon'ble Mr. Justice C. Harishankar were pleased to appoint me as the Local Commissioner to physically visit Fair Price Shops in the area of Malviya Nagar by randomly selecting the said shops and to also interact with the residents on whose behalf the Petitioners have filed the affidavits, residing in the settlement colonies around Malviya Nagar, commonly known as Jagdamba and Lal Gumbad Camps. This Hon'ble Court was pleased to observe broadly two areas of grievances expressed by the Petitioners viz. (1) their names not being recorded in the Ration Cards of the families due to want of Aadhaar and (2) Difficulty faced on account of the "Point of Service"/"Point of Sale" machines not working because of biometric failures especially with regard to old people.

I. Names not being recorded in Ration Card of family members due to want of Aadhaar.

2. That pursuant to the above directions on 05.08.2017, Saturday, I along with the representatives of the Petitioner, Ms. Amrita Johari and her colleagues visited the area of Jagdamba and Lal Gumbad camps to meet with the 39 families who had filed their affidavits before this Hon'ble Court expressing more or less an identical nature of grievance, namely that an application of their family members for enlisting them in the Ration Card was made with a birth certificate as proof of identity but the same was refused to be added to the Ration Card for not submitting Aadhaar number as proof of identity. It must be noted that all these applications of the 39 families were made between 16.09.2013 to 2015. It is pertinent to note that at that time the Aadhaar (Targeted Delivery of Financial and other Subsidies, benefits and services) Act, 2016 was not in place and the stand of the Union of India was also that Aadhaar is voluntary. It is only from September 2016 and more specifically in the case of food subsidies, from the introduction of the impugned notification dated 8.02.2017, can it be said that Aadhaar is a requirement to avail of food subsisdies. Prior to the introduction of the

Aadhaar (Targeted Delivery of Financial and other Subsidies, benefits and services) Act, 2016, it was the Supreme Court's orders which held the field. The Hon'ble Supreme Court vide its Order dated 23.09.2013 in W.P. (C) No. 494 of 2012 had held that no person should suffer for not getting the Aadhaar Card. The relevant extract of the order is quoted hereinafter:

"In the meanwhile, no person should suffer for not getting the Adhaar card inspite of the fact that some authority had issued a circular making it mandatory and when any person applies to get the Adhaar Card voluntarily, it may be checked whether that person is entitled for it under the law and it should not be given to any illegal immigrant."

3. A similar order was reiterated by the Supreme Court on subsequent occasions and even the Union of India had given wide publicity to the fact that Aadhaar is voluntary. Therefore, at the time when the applications were made by these 39 applicants, Aadhaar was not mandatory. In any event the notification requiring Aadhaar for accessing food subsidies under the National Food Security Act has come into effect from 08.02.2017 which lays down a detailed mechanism for the same.

4. That, during my inspection of the Jagdamba and Lal Gumbad colonies, I have met each and every one of the 39 families including several of the members of their family by visiting their houses which are basically "jhuggis", who stood excluded from the Ration Card and consequently the benefits under the National Food Security Act, 2013 on 5th August, 2017. I was repeatedly reminded of the expression which has been used by the Hon'ble Supreme Court quoting Field, J. in Munn v. Illinois, 1877 94 US 113 that "life means something more than mere animal existence" as quoted by the Supreme Court in Olga Tellis and Ors. v. Bombay Municipal Corporation and Ors., 1985 3 SCC 545 and how these people were barely exercising that right.

5. That, the following chart provides the names and particulars of the persons who have filed affidavits before this Hon'ble Court and the number of their family members who stood excluded from the food subsidies as their names were not updated on the Ration Card for not supplying their Aadhaar number while making the application somewhere between the periods of September, 2013 and 2015. Almost all of them have stated that they have made the applications for inclusion in the Ration Card with the Birth Certificate which was rejected

by the Food Department, Govt. of NCT of Delhi on the pretext that Aadhaar Card was required. Subsequently almost all of the family members of the above applicants who were hitherto excluded for want of Aadhaar have applied for Aadhaar and obtained the same. Even after obtaining the Aadhaar Number and after making fresh applications with their Aadhaar Number they were told that their names cannot be included in the Ration Card because the quota for the year is over and only when the next window is open will it be done.

- 6. That, all the above applicants have received identical responses from the Food Department, Government of NCT of Delhi that since their family members did not have Aadhaar while applying for their ration card between 2013 and 2015, their names would not be added.
- 7. On 26.08.2017, I held a three-hour long meeting with the Food Commissioner of the Govt. of NCT of Delhi, Shri K.R. Meena along with Special Commissioner Shri Arun Kumar Mishra, Senior System Analyst Shri M.M. Chandra, Assistant Commissioner (Food and Supply) Shri Arvind Kumar, the FSO Circle - 50 - Shri R.K. Kannaujia, FSO Circle - 20, 21- Shri S.P. Singh and FSO Circle - 38 - Shri Manish. I apprised the Food Commissioner and the other officials of the above situation and also impressed upon them that since all the applicants and their family members have reapplied with their Aadhaar numbers, there cannot be any reason to further continue to deny those family members their food subsidies under the National Food Security Act. Pursuant to our discussion, the Food and Supply Department, Circle - 50 has filed an Action Taken Report and I am informed that 62 out of 81 family members of the 39 families have now been included in the ration card and will be entitled to their regular supply of Ration under the National Food Security Act. I am also informed that all the above 62 family members will now get

their quota of food subsidies form the next cycle of allocation i.e. October, 2017 onwards. Out of the remaining 19, 8 are yet to apply for addition of their names to the card and I have been assured by the Assistant Commissioner in the Action Taken Report that as soon as the application of these 8 persons are received, their names will be added to the family ration card.

A Copy of the Action Taken Report filed by the Food and Supply Department, Circle – 50 is attached herein as Annexure LC-4.

- 8. That at this juncture, I must revisit the impugned notification dated 8th February, 2017 of the Ministry of Consumer Affairs, Food and Public Distribution and quote Para 5 therein
 - "5. Notwithstanding anything in above paragraphs, any member of eligible household listed in the Ration Card shall be entitled to receive the entire quantity of entitled subsidized food grains or Cash Transfer of Food Subsidy under NFSA, if any one member of the household in the Ration Card fulfills the identification conditions mentioned in above clauses, in case Aadhaar numbers is not yet assigned to all such members of the household."
- 9. That therefore, it is apparent from a plain reading of the above notification that the Food Ministry of the Central Government while exercising its power under the National Food Security Act, 2013 and Section 7 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, benefits and services) Act, 2016

has laid down a mechanism which takes care of the fact that till Aadhaar is assigned, no person shall be denied of their entitlement. In light of the above extract of the notification it is also evident that if any one member of the family either has Aadhaar, then other members of such eligible household in the Ration Card shall not be denied their entitled subsidized food grains for not having Aadhaar. Therefore, as long as any one family member of the household has Aadhaar, the other members of the family of the eligible household could not have been denied their food entitlement for want of Aadhaar. Even if someone does not have Aadhaar, the impugned notification requires the person to apply for Aadhaar and in the meanwhile until Aadhaar is assigned she cannot be denied of her entitlements if she furnishes a valid alternate ID like the Voter ID card or PAN card or Passport or Driving License or ID by a gazetted officer or Tehsildar or Address Card issued by Department of Post or Kissan Photo Book or any other document as specified by the State Government.

10. In any event, the initial applications of all the above applicants could not have been rejected during the years 2013-2015 for want of Aadhaar for the simple reason that at that time Aadhaar was not mandatory and could not have been insisted upon to deny any person their food subsidy under the National Food Security Act, 2013. Even after the coming into effect of the Aadhaar Act and the relevant provisions from 12th

September, 2016 till the coming into force of the notification dated 8th February, 2017 Aadhaar could not have been insisted upon for supply of food subsidies since the power under Section 7 had not been operationalised during that period. It is only after the coming into force of the impugned notification dated 8th February, 2017 that Aadhaar was made a requirement for availing food subsisdies, pursuant to the enabling provision of Section 7 of the Aadhaar Act, 2016. It must be noted that even under this notification all eligible beneficiaries who do not possess Aadhaar number or are not yet enrolled for Aadhaar must apply for Aadhaar enrollment by 30th June, 2017, if they are desirous of availing food subsidies and till such Aadhaar Number is assigned, the alternate identification documents along with the Aadhaar enrollment slip or a request of Aadhaar enrollment would be sufficient to avail food subsidies. It has come to my knowledge that the above deadline of 30th June, 2017 has also been extended by the Government of India to 30th September, 2017 by an Office Memorandum dated 22nd June, 2017.

A Copy of the Office Memorandum dated 22.06.2017 issued by the Government of India is marked as Annexure LC-5.

11. Thus, it is apparent that the executive and the legislative intent is to introduce Aadhaar in a phased manner without causing hardship to genuine beneficiaries and as already observed above, if any one member of the household in the Ration Card fulfills the above identification conditions then no other member of the same household can be denied food subsidy for want of Aadhaar.

- 12. Therefore it appears that not only were the applications of the family members of the 39 families wrongly rejected, their continued denial and exclusion from food subsidies is also contrary to the express provisions of the Notification dated 8th February, 2017 as the law itself provides that no person shall be deprived of benefits if any one member of the family has Aadhaar. In all the above 39 families atleast one member of such household has Aadhaar and therefore their denial is contrary to the law.
- 13. That this Hon'ble Court may also consider awarding compensation to the excluded family members or their guardians for the period for which each of the family members has been denied their quota of the food subsidy which could be equivalent to the fair market value of their monthly entitlement of Rice and Wheat. The reason I make this suggestion is twofold
 - a. The Supreme Court has repeatedly held that Right to Life guaranteed in any civilized society would take within its sweep the Right to Food (Chameli Singh and others etc. v. State of U.P. and anr. (1996) 2 SCC 549: M/s.

Shantistar Builders v. Narayan Khimalal Totame and others AIR 1990 SC 630) and

- b. All these families are living in abject poverty and barely managing to survive.
- 14. In fact, if I may recall one instance of one of the above families I met during inspection where a boy named Nitin, son of Ms. Anita, one of the applicants, who is nine years old and suffers from serious handicap displaying symptoms of chronic autism. He is one such person on whose behalf his mother had applied for inclusion in the Ration Card with birth certificate but was refused enlistment in the Ration Card for not possessing Aadhaar. The application was made apparently on 13.03.2014 when Aadhaar was not even mandatory for availing food subsidies. In fact this was also the stand of the Union of India at that time. I am glad to inform that Nitin and his younger brother Ayush, who is seven years old, have both been included in the ration card pursuant to this Hon'ble Court's intervention. There may be several cases like this where the impugned notification dated 8.2.2017 is not being followed in letter or spirit by the implementing authorities and therefore, it is incumbent on the concerned authorities to clearly issue guidelines and directions in order to ensure strict compliance with the law. Those excluded from the food subsidies have suffered hardships and may be compensated by the Food Department of State of NCT of Delhi, if this Hon'ble Court deems fit.

15. That, the Delhi Government has also brought to my attention two circulars issued by them dated 23.06.2014 as well as 13.03.2015 which note that at that time the benefits of food security were to be provided even without Aadhaar Number if someone did not have Aadhaar. Therefore, in 2014 and 2015 any denial by the Food department of the Govt. of NCT of Delhi is ex-facie illegal, even according to their own circulars.

- 16. While parting with this issue, I may suggest that strict compliance with the letter and spirit of the notification date 8th February, 2016 would go a long way in alleviating the hardships faced by the beneficiaries and if any one member of the household has Aadhaar then as per the notification itself, the other members of the household cannot be denied their food subsidies for not possessing Aadhaar. Being a welfare legislation, a view in favour of the beneficiaries may be taken and in this case the provision of the notification already provides such a relief which the authorities cannot deny to the beneficiaries.
- II. Exclusions, if any, on account of "Point of Service"/"Point of Sale" device

- 17. On 19th August, 2017, I visited two Fair Price Shops (FPS) operated in two different localities for inspecting the functioning of these FPS shops and the Point Of Sale (POS) devices.
- 18. My first visit was to Fair Price Shop No. 7795 known by the name of M/s Laxmi Provision Stores, located at 40-A, DDA Flats, Mata Sundari Road, New Delhi. My observations with respect to this inspection are as follows.
- 19. I reached the location of the shop at 3.45 P.M. and found the shop to be shut with no notice, display board, or information regarding the timings publicly displayed in the shops premises. On calling the Food Department and informing them about the FPS Shop being shut down, I was told that the operator might have gone for lunch, even though it was not lunch time. It was only on informing them that I was a Court appointed Commissioner that I was told that the owner will be informed and directed to be there and open the shop immediately. A person called Mr. Krishna arrived at the shop and opened the shop. On enquiry, he informed me that he was the Sales Manager of the shop. The shop was owned by one Mr. Pawan Kumar. He informed me that they were no longer providing food grains by way of Aadhaar based authentication since the contract for the POS device had expired and they were following the old system of Sale/Case Register. He also

informed me that there were some problems with the POS device and he had made complaints to the authorites. But since April-May 2017, they have been providing rations to the beneficiaries manually. He showed us the register wherein he kept such record of quantity of food grains sold to a person against the Ration Card Number of that person. Mr. Krishna further informed us that the POS device was installed in this shop in the year 2014 and they used it till May 2017. On being categorically asked whether the rations were denied to anybody for failure of authentication, Mr. Krishna said they did not deny anybody rations for authentication failure and used to supply them their entitlements based on their ration cards. According to Mr. Krishna on failure of authentication through the POS device, they would use a alternative method to provide rations by allowing the person to purchase rations by using the aforementioned Sale/Cash-Register system. Sometimes they would ask the person to return to their home and ask someone else from the family having their name in the Ration Card to come to the FPS shop, authenticate himself or herself and then collect the rations for the family. Mr. Krishna also said that even in a case where there is a one member Ration Card and the POS device failed to authenticate that person, he would provide such person with rations after confirming his or her ID manually against the name mentioned on the Ration Card.

1

- 1. My second visit on the same day was to Fair Price Shop No. 8535 known by the name of M/s Musrat Jahan located in Chandni Chowk since some of the affidavits were also filed from this area. My observations with respect to the inspection of this Fair Price Store was as follows.
- 21. I reached the FPS shop at 5.00 P.M. in the evening and the shop was shut down. On enquiring with the neighbors, the owner was called for and a person by the name of Mr. Mohhammad Tausif came to the location and opened the store. On enquiring from him I found out that he was the operator of the store. Mr. Tausif informed me that he had installed the POS device at his shop in the month of October, 2014. The device was having frequent issues and he would register complaints with the authorities. Mr. Tausif said that POS Device developed a charging problem and he made a complaint to the Assistant Commissioner, F&S Department, District Central (AC Central), to which he received a response saying, "toh hum kya karen" (so what can we do), which is recorded in an email, which he has forwarded to me. [A Copy of the email dated 8th September 2016 is marked as Annexure LC-8]. Mr. Tausif also claimed that there was no help from the food department officials despite various complaints.

- I placed the above scenario before the Food Commissioner and the officials in my meeting with them and also the non chalant conduct of the AC Central.
- 23. The Food Commissioner has brought to my attention an email dated August 28, 2017 which provides for manual distribution of food grains if the POS device is not working in the Fair Price Shops as a means to alleviate any hardships. [A Copy of the Email dated August 28, 2017 is marked as Annexure LC-9]
- 24. The Food Commissioner has also informed that they have entered into a System Integrator's Service Agreement with Bharat Electronics Limited on 4th August 2017 for Fair Price Shop End to End Computerisation of Targeted Public Distribution System and they have asked them to do a survey of network connectivity in entire region of Delhi and also identify areas with network issues where they will take preventive measures and have offline distribution to avoid any denials to genuine beneficiaries.
- 25. I have pointed out to the Food Commissioner that even Section 7 of the Aadhaar Act, 2016 states that furnishing proof of Aadhaar can suffice:
 - "7. The Central Government or, as the case may be, the State Government may, for the purpose of establishing identity of an individual as a condition for receipt of a subsidy, benefit or

service for which the expenditure is incurred from, or the receipt therefrom forms part of, the Consolidated Fund of India, require that such individual undergo authentication, or furnish proof of possession of Aadhaar number or in the case of an individual to whom no Aadhaar number has been assigned, such individual makes an application for enrolment:"

26. The Food Commissioner tried to impress upon me the benefits of Aadhaar that they have received. According to the Food Commissioner, the use of Aadhaar as identity document for delivery of subsidies or benefits simplifies the delivery process, brings transparency and efficiency and enables beneficiaries to get their entitlements directly in a convenient and seamless manner. According to him, the Government has already recorded a savings of \$% on account of Aadhaar based authentication system. He stated that there is a nexus between shop-keepers and inelgible beneficiaries. He has handed over a Status Note which inter alia also reiterates that if any one member of the household has Aadhaar or fulfils the identification requirement as per the Notification dated \$.2.2017, then the other members of the household cannot be denied their food subsidies.

A Copy of the Status Note submitted by the Food Commissioner is attached herein as Annexure LC-10

27. The Food Commissioner has also informed that moving forward, there will not only be fingerprint authetication

because sometimes there are some manual workers whose fingerprints do not work due to wearing off of the ridges and therefore, they are introducing the iris based authentication as well as an alternative where the iris of the concerned individual will be matched with that in the database. If neither of these work for some individuals, he has informed that they will not deny any genuine beneficiary and follow the One Time Password or OTP system where the password will be sent to the registered Mobile Phone number of the beneficiary.

28. The representatives of the Petitioners have expressed their concerns about exclusions on account of biometric failure and according to them there are people who are old and infirm who are unable to present themselves at POS Shops and therefore some alternative may be suggested for those vulnerable categories. The Petitioners have also expressed that the exact figures of biometric authentication failures in the 2 years of the Pilot Project would be helpful in understanding the system better and if any remedial measures are required. However, the figure that would be required is biometric authentication failure of genuine beneficiaries. It is clear that manual override was allowed by the Food Department, therefore, in order to ensure that no hardship is caused, the State Government should place all these particulars of the pilot project conducted over the last 2 years in a comprehensive report so that remedial measures if any can be taken well in time.

III. General observations on the working of the NFSA Act.

Even though I have not been specifially asked to look into the National Food Security Act, I feel that many of the problems faced by the people could have been obviated by suitable interventions at the statutory level by following the existing law. I was informed by the representatives of the Petitioners that various provisions of the National Food Security Act, 2013 which contain a statutory mandate of transparency and accountability as well as grievance redressal are not being followed at all. For instance, Section 14 of the National Food Security Act, 2013 requires an internal grievance redressal mechanism and rules to be prescribed therein. I am told that there are no rules to that effect. Even complaints registered with the helplines (the Helpline Number being 1967), are not visible to the concerned person and its status cannot be tracked. Ideally all of this should be recorded in an Management Information System (MIS) which should be accessible to the person making the complaint and a unique number should be assigned to enable them to track their specific complaint. Section 28 requires periodic social audits but I am told that it has not happened even once. Section 27 under chapter 9 which deals with transparency and accountability and states that all targeted public distribution system related records must be placed in the public domain and kept open for inspection to the public. Since the

beneficiaries of these programs are not internet savvy, apart from online MIS there should also be physical copies of the MIS containing the names of all beneficiaries, entitlements and whether they have availed of the food subsidy in a particular month or not and to what extent should all be available both in the ration shop as well as the Circle office as per the requirement of the law. Section 15 pertains to District Grievance Redressal Officer, who should ideally be an independent officer and Section 16 deals with the State Food Commission, which I am informed is also not yet in place. Of the two Ration shops I visited randomly sometime between 4 o'clock and 5 o'clock on a day when they are supposed to be open, both were found closed. There are around 2500 Fair Price Shops in the National Capital Territory of Delhi, this Hon'ble Court may even consider directing CCTVs to be installed in all these shops with an online feed directly in the website of the food department, which would go a long way in checking any nexus with bogus elements and shopkeepers. The report is submitted accordingly.

New Delhi, the 8th February, 2017

S.O. 371(E).— Whereas, the use of Aadhaar as identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner and Aadhaar obviates the need for producing multiple documents to prove one's identity;

And whereas, implementation of relevant provisions of the National Food Security Act, 2013 (hereinafter referred to as NFSA), through Targeted Public Distribution System (hereinafter referred to as TPDS) and Cash Transfer of Food Subsidy Rules, 2015 issued under the said National Food Security Act, 2013, involves recurring expenditure from the Consolidated Fund of India;

Now, therefore in pursuance of the provisions of the Section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (hereinafter referred to as the said Act), the Central Government hereby notifies the following, namely: --


- 1. (1) An individual eligible to receive the subsidised food grains or Cash Transfer of Food Subsidy under NFSA and having valid Ration Cards issued by State Governments or Union Territory Administrations is hereby required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication. Any new eligible beneficiary who is selected by State Governments or Union Territory Administrations for receiving subsidised food grains or Cash Transfer of Food Subsidy under NFSA is also required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication as stated in ensuing clauses.
 - (2) All such eligible beneficiaries entitled to receive subsidised food grains or Cash Transfer of Food Subsidy under NFSA, who do not possess the Aadhaar Number or, are not yet enrolled for Aadhaar, but are desirous of availing subsidised food grains or Cash Transfer of Food Subsidy under NFSA are hereby required to make application for Aadhaar enrolment by 30th June, 2017, provided he or she is entitled to obtain Aadhaar as per Section 3 of the said Act. All such individuals may visit any Aadhaar enrolment centre (list available at www.uidai.gov.in) to get enrolled for Aadhaar.
 - (3) As per regulation 12 of Aadhaar (Enrolment and Update) Regulations, 2016, the State or Union Territory Administration Food Department which requires an individual to furnish Aadhaar is required to offer enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrolment centre located in the respective Block or Taluka or Tehsil, the State or Union Territory Food Department is required to provide enrolment facilities at convenient locations in coordination with the UIDAI or the existing Registrars of UIDAI or by becoming UIDAI registrar themselves:

Provided that, till the Aadhaar is assigned to the beneficiaries of subsidised food grains or Cash Transfer of Food Subsidy under NFSA, subsidy or benefits under NFSA shall be given to such individual, subject to the production of the following identification documents, namely:

- (a) Ration Card issued by the State or Union Territory Administration Food Department; and
- (b) (i) If he or she has enrolled, his or her Aadhaar Enrolment ID slip; or
 - (ii) a copy of his or her request made for Aadhaar enrolment, as specified in sub-paragraph (2) of Paragraph 2; and
- (c) (i) Voter ID card issued by the Election Commission of India; or (ii) Permanent Account Number Card issued by Income Tax Department; or (iii) Passport; or (iv) Driving License issued by Licensing authority under Motor Vehicles Act, 1988 (59 of 1988); or (v) Certificate of Identity having photo issued by the Gazetted officer or Tehsildar on an official letter head, or (vi) Address card having Name and Photo issued by Department of Posts; or (vii) Kisan Photo Passbook; or (viii) any other document as specified by the State Government or Union Territory Administration.

Provided further that the above documents shall be checked by an officer designated by the State/UT Food Department for that purpose.

2. In order to provide convenient and hassle free subsidised food grains or Cash Transfer of Food Subsidy under NFSA to beneficiaries, the State or Union Territory Administration Food Department shall make all the required arrangements including following, namely:-



(2) In case, beneficiaries of subsidised food grains or Cash Transfer of Food Subsidy under NFSA are not able to enrol due to non-availability of enrolment centres in the

near vicinity such as in the Block or Tehsil or Taluka, the State or Union Territory Food Department are required to provide enrolment facilities at convenient locations in coordination with the UIDAI or the existing Registrars of UIDAI or by becoming UIDAI registrar themselves and the beneficiaries of subsidised food grains or Cash Transfer of Food Subsidy under NFSA may register their request for enrolment by giving their name, address, mobile pumber with Ration Card number and other details specified in the proviso to sub-paragraph (3) of paragraph 1 with their fair price shop owners or through the web portal provided for the purpose.

- This notification shall come into effect from the date of its publication in the Official Gazette in all States and Union Territories except the States of Assam, Meghalaya and Jammu and Kashmir.
- 4. The State Government or Union Territory Administration shall, within a period of thirty days from the receipt of proof of possession of Aadhaar number furnished by individual beneficiaries of the eligible household, link the Aadhaar number with the Ration Card issued to such household or with Bank Account for Cash Transfer of Food Subsidy.
- 5. Notwithstanding anything in above paragraphs, any member of eligible household listed in the Ration Card shall be entitled to receive the entire quantity of entitled subsidised food grains or Cash Transfer of Food Subsidy under NFSA, if any one member of the household in the Ration Card fulfils the identification conditions mentioned in above clauses, in case Aadhaar number is not yet assigned to all such members of the household.

Subject: -Extension of stipulated date for Aadhaar Enrolment as mentioned in various Notifications issued by Central Ministries under Section 7 of Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 upto 30th September, 2017.

The use of Aadhaar as identifier for delivery of services/benefits/subsidies simplifies. Government delivery processes, brings in good governance, transparency and efficiency, and enables beneficiaries to get their entitlements directly to them in a convenient and hassle free manner. Aadhaar obvious the need for producing multiple documents to prove identity.

- 2. The Central Ministries for the purpose of using Aadhaar for delivery of services, benefits and subsidies funded from the Consolidated Fund of India have issued notifications under Section 7 of the Aadhaar Act. The list of such notifications is given in Annexure. The Notifications inter alia mention the stipulated dates by which the beneficiaries of the respective scheme shall have to provide Aadhaar number or to apply for Aadhaar enrolment.
- 3. In order to facilitate convenient and seamless delivery of services/benefits/subsidies covered by these notifications to the intended eligible heneficiaries and avoid hardships to such beneficiaries, it has now been decided to extend the stipulated date in the notifications to 30th September, 2017 (wherever stipulated date is prior to 30th September, 2017), for only those beneficiaries who have not enrolled for Aadhaar, it is further clarified that this extension shall only apply to those beneficiaries who are not assigned Aadhaar number or those who have not enrolled for Aadhaar. Such beneficiaries are required to enroll for Aadhaar by 30th september, 2017 and provide their Aadhaar number or enrolment ID as required under the respective notifications issued under Section 7 of the Aadhaar Act.
- 4. For such beneficiaries when have not enrolled for Aadhaar, the respective Ministries/Departments should facilitate their Aadhaar enrolments through appropriate measures, in accordance with Regulation 12 of Aadhaar (Enrolment and Update) Regulations, 2016 and ensure that the benefits are continued to them on the basis of alternate means of identification till they are assigned Aadhaar numbers in accordance with Section 7 of the Aadhaar Act.
- 5. The respective Ministries/Departments should also take special measures to issue Aadhaar numbers to women, children, senior citizens, persons with disability, unskilled and unorganized workers, nomadic tribes or to such other persons who do not have any permanent dwelling house etc. in accordance with Section 5 of the Aadhaar Act, 2016, to ensure that the services/benefits are not denied to the eligible beneficiaries.

6. The respective Ministries/Departments should issue necessary orders in this regard and provide wide publicity for the information of their beneficiaries and public at large.

CIRCULAR

- In case an applicant does not have Aadhaar number, he may be 1. allowed to fill in the Audhaar enrollment ID (EID) number in the application form.
- In case the person does not have either Aadhaar or EID, he should 2. be facilitated to enroll for Aadhaar at the nearest enrollment centre by the FSO and his EID number should be obtained. The department is also opening Aadhaar enrollment centers in district offices, which may be used for quick enrollment.
- In case the applicant refuses to enroll for Aadhaar, he should be requested to give his/her National Population Register (NPR) 3. number.
- In case the applicant is unable to provide NPR number, his/her NPR details should be obtained from the Directorate of Census 4. Operations, Delhi and entered in the system. Before doing that, the details of the applicant should be matched with Aadhaar data to rule out his enrollment for Aadhaar.

All Assistant Commissioners & FSOs must strictly comply with the above directions.

STATUS NOTE

A - Brief note on capturing of Aadhar Number of beneficiares under NFS.

The National Food Security Act, 2013 has been rolled out in Delhi on 20.08.2013. Subsequently implemented from 1st September, 2013. The National Food Security Ordinance, 2013 has been implemented w.e.f. 01/09/2013 vide Cabinet Decision No. 2051 dated 25/07/2013.

Under Section 12© of NFS Act leveraging "aadhaar" for unique identification, with biometric information of entitled beneficiaries for proper targeting of benefits under this Act; and full transparency of records.

Benefits of Aadhar linking with ration cards:-

Aadhar updation of ration card holders would give us the correct picture and Aadhar seeding would definitely ensure better transparency, and work to reduce the level of ration card fraud in PDS. Linking the ration card system to Aadhar, a great level of security can be achieved and that the system will be easier for the public service to manage, and ghost cards would be invalided.

The use of Aadhar as identity document for delivery of services or benefits or subsidies simplifies the delivery processes, brings in transparency and efficiency and enables beneficiaries to get their entitlements directly in a convenient and seamless manner.

Aadhar linking with the ration card will save food grains inventories from being fraudulently distributed under PDS.

The National Food Security Act, 2013 was implemented with the idea of providing ration at cheap rates to individuals from poor backgrounds. Thousands of families have benefitted under this scheme, utilising their ration cards to get food grains at subsidised prices. The Govt. of India issued the threshold limit upto 72.78.lakh People close to 72.91 lakh have applied for ration cards.

Govt of India notification dated 08.02.17 states that the beneficiaries under NFSA who do not possess the Aadhar number or are not yet enrolled for Aadhar, but are desirous of availing subsidies under NFSA are required to make application for Aadhar eurolment by 30.06.2017 which is as under:-

Provision has also been made that any member of eligible household listed in the Ration card shall be entitled to receive the entire quantity of entitled subsidized food grains or Cash transfer of Food subsidy under NFSA, If any one member of the bousehold in the Ration card fulfils the identification conditions in case Aadhar number is not yet assigned to all such members of the household.
