<u>India's Active Caseload stands at 1.46 lakh today; Daily recoveries more than the daily new cases</u> <u>in the last 24 hours, India's Cumulative Vaccination coverage has crossed 1.21 crore</u>

India has been containing the country's Active Caseload under 1.50 lakh. The active cases are 1,46,907 today. The present active caseload now consists of 1.33% of India's total Positive Cases.13,742 new daily cases have been recorded in the last 24 hours whereas 14,037 recoveries registered in the last 24 hours. It has led to a net decline of 399 cases in the total active caseload. Maharashtra reported maximum positive changes with an addition of 298 cases whereas Kerala has recorded maximum negative change with subtraction of 803 cases. In last one week, 12 states have reported more than 100 average daily new cases. These are Maharashtra, Kerala, Tamil Nadu, Karnataka, Punjab, Gujarat, Madhya Pradesh, Chhattisgarh, West Bengal, Telangana, Delhi and Haryana. Two States, Kerala and Maharashtra both report more than 4,000 average daily new cases in past one week. As on 24th February, 2021, the vaccination coverage was 1,21,65,598 through 2,54,356 sessions, as per the provisional report till 7 am today. These include 64,98,300 HCWs (1st dose), 13,98,400 HCWs (2nd dose) and 42,68,898 FLWs (1st dose). The 2nd dose of COVID19 vaccination started on 13th February, 2021 for those beneficiaries who have completed 28 days after receipt of the 1st dose. Vaccination of the FLWs started on 2nd Feb 2021.On Day-39 of the vaccination drive (23rdFebruary, 2021), 4,20,046 vaccine doses were given. Out of which, 2,79,823 beneficiaries were vaccinated across 9,479 sessions for 1st dose (HCWs and FLWs) and 1,40,223 HCWs received 2nd dose of vaccine.Out of total 1,21,65,598 vaccine doses, 1,07,67,198 (HCWs and FLWs) have received 1st dose of vaccine and total **13.98.400** HCWs have received the 2nd dose of vaccine.12 States/UTs have administered more than 75% of the registered HCWs.India's cumulative recoveries stand at 1,07,26,702 today. The Recovery Rate is 97.25% today. The gap between total recovered cases and the active cases is constantly rising and stands at 10,579,795 today.86.26% of the new recovered cases are observed to be concentrated in 6 States. Maharashtra has reported the maximum number of single day recoveries with 5,869 newly recovered cases.4,823 people recovered in Kerala in the past 24 hours followed by 453 in Tamil Nadu.86.15% of the new cases are from 6 States.Maharashtra continues to report the highest daily new cases at 6,218. It is followed by Kerala with4,034 while Tamil Nadu reported 442 new cases.104 deaths were reported in the last 24 hours. Five States account for 81.73% of the new deaths. Maharashtra saw the maximum casualties (51). Kerala reported 14 deaths and Punjab reported 10 deaths.19 States/UTs have not reported any COVID19 deaths in last 24 hours. Thirteen states have reported 1 to 5 deaths; 2 states have reported 6 to 10 deaths; 1 state has reported 10 to 20 deaths and 1 state has reported more than 20 deaths.

<u>Centre Rushes Multi-disciplinary High Level Central teams to States/UTs witnessing surge in cases, Health Secretary writes to 7 States/UTs on Recent Surge in COVID19 Cases & advises specific measures to be taken</u>

The Centre has deputed high level multi-disciplinary teams to Maharashtra, Kerala, Chhattisgarh, Madhya Pradesh, Gujarat, Punjab, Karnataka, Tamil Nadu, West Bengal and Union Territory of Jammu and Kashmir for supporting them in public health measures for targeted COVID response and management, and effectively tackling the pandemic. The three -member multidisciplinary teams are headed by Joint Secretary level officers in the Health Ministry. These teams will work closely with the States/UT administration and ascertain reasons for recent surge in the number of COVID19 cases. They will also coordinate with health authorities of the States/UT for requisite COVID19 control measures to break the chain of transmission. The States/UT has been advised for regular critical review of the emerging situation with concerned District officials to ensure that gains made so far in COVID management are not lost. The Centre has also written to Maharashtra, Kerala, Chhattisgarh, Madhya Pradesh, Gujarat, Punjab and Union Territory of Jammu and Kashmir which have been witnessing a rise in daily COVID cases, along with decreasing proportion of RT-PCR tests and rise in positivity in some districts. They have been asked to focus on undertaking aggressive measures to break the chain of transmission and to ensure that RT-PCR testing is amplified to flush out hitherto undetected cases from the population. These States/UT have been advised to increase testing in a focussed manner in the affected districts with the appropriate split of RT-PCR and Rapid Antigen Tests and to also ensure that all symptomatic negatives of antigen tests are compulsorily tested via RT-PCR tests.

Cabinet approves Production Linked Incentive Scheme for Pharmaceuticals

The Union Cabinet, chaired by the Prime Minister, Shri Narendra Modi has approved Production Linked Incentive (PLI) Scheme for Pharmaceuticals over a period of Financial Year 2020-21 to 2028-29. The Scheme will benefit domestic manufacturers, help in creating employment and is expected to contribute to the availability of wider range of affordable medicines for consumers. The scheme is expected to promote the production of high value products in the country and increase the value addition in exports. Total incremental sales of Rs.2,94,000 crore and total incremental exports of Rs.1,96,000 crore are estimated during six years from 2022-23 to 2027-28. The scheme is expected to generate employment for both skilled and un-skilled personnel, estimated at 20,000 direct and 80,000 indirect jobs as a result of growth in the sector. It is expected to promote innovation for development of complex and high-tech products including products of emerging therapies and in-vitro Diagnostic Devices as also self-reliance in important drugs. It is also expected to improve accessibility and affordability of medical products including orphan drugs to the Indian population. The Scheme is also expected to bring in investment of Rs.15,000 crore in the pharmaceutical sector.

States/UTs roll out Intensified Mission Indradhanush (IMI) 3.0

Various States and UTs have started implementation of the Intensified Mission Indradhanush 3.0, a campaign aimed to reach those children and pregnant women who have been missed out or been left out of the Routine ImmunisationProgramme. This is aimed to accelerate the full immunization of children and pregnant women through a mission mode intervention. The first phase has been rolled out from 22nd Feb 2021 for fifteen days. The Union Minister for Health and Family Welfare, Dr Harsh Vardhan, launched the campaign on 19th February, 2021 and urged the States and district functionaries to reach each and every child and attain maximum Full Immunization Coverage. The campaign has exemplified ownership of the immunization program by top most leadership at the state level also. The campaign is scheduled to have two rounds of immunization lasting 15 days (excluding Routine immunization and holidays). It is being conducted in pre-identified 250 districts/urban areas across 29 States/UTs in the country. As per the Guidelines released for IMI 3.0, the districts have been classified to reflect 313 low risk; 152 as medium risk; and 250 as high risk districts. As per data reported till 1700 hrs. on 22nd February, nearly 29,000 children and 5,000 pregnant women were vaccinated (data provisional).IMI 3.0 campaign spearheaded by the Ministry of Health and Family Welfare (MoHFW), will be implemented in mission-mode with support from key departments, as well as a strong network of partners and civil society organizations, youth groups, and community members.

The Prime Minister addressed a workshop on "Covid-19 Management: Experience, Good Practices and Way Forward" with health leaders, experts and officials of 10 Neighboring Countries viz Afghanistan, Bangladesh, Bhutan, Maldives, Mauritius, Nepal, Pakistan, Seychelles, Sri Lanka along with Indian officials and experts, on Thursday. The Prime Minister lauded the way the health systems of the countries cooperated during the pandemic and for meeting the challenge in the most densely populated region with coordinated response. The Prime Minister recalled creation of COVID-19 Emergency Response Fund to meet the immediate costs of fighting the pandemic and sharing of resources - medicines, PPE, and testing equipment. He also notedsharing of experiences and learning from each other's best practices in testing, infection control and medical waste management. "This spirit of collaboration is a valuable take-away from this pandemic. Through our openness and determination, we have managed to achieve one of the lowest fatality rates in the world. This deserves to be applauded". Asking the countries to raise the ambition further, the Prime Minister suggested creating a special visa scheme for our doctors and nurses, so that they can travel quickly within our region during health emergencies, on the request of the receiving country.

Dr. Harsh Vardhan addresses the inaugural ceremony of the third India Tourism Mart

Dr. Harsh Vardhan, Union Minister for Health and Family Welfare addressed the inaugural ceremony of the third India Tourism Mart, organized by the Federation of Associations in India Tourism and Hospitality (FAITH), through video conferencing on Thursday. Congratulating FAITH for organising the event, Dr. Harsh Vardhan expressed his appreciation at the participation of over 250 delegates from 60 countries who attended the event virtually. He also added that, "This third India Tourism Mart holds even more significance as it is being organized at a time when the world is emerging from the dark clouds of the pandemic and countries all across the world are contemplating on opening up travel albeit with all health & security precautions in place." Highlighting the government's efforts in controlling the Covid-19 pandemic, Dr Vardhan said, "India has embarked on the world's largest immunization program against COVID-19. We have not only vaccinated over 8.5 million people in India but have also sent millions of doses to other countries seeking our help." Speaking on the advancements in India's healthcare facilities which has led to a spike of medical tourism in India, the Minister noted that, "India has always been a popular tourist destination, but over the last few years, it has also emerged as a leading destination for medical tourism. He further said that to encourage it further, we have already started issuing medical visas and are planning to soon restart E-Tourist Visas as well as scheduled International flights".

Gangwar launches Software Applications and instruction manuals with questionnaire for five All India Surveys; Says labour data is crucial inputs in policy making

Union Minister of State (Independent Charge) for Labour& Employment Shri Santosh Kumar Gangwar today launched the trainers' training programme for the All India Surveys being conducted by Labour Bureau, an attached office of Ministry of Labour& Employment by releasing the Instruction Manuals & Questionnaires for the surveys and the software application developed. He was accompanied by Secretary L&E Shri Apurva Chandra and Senior Labour& Employment Advisor and Director General, Labour Bureau Shri DPS Negi. Speaking on the occasion, Union Labour Minister said that data on all aspects of labour is crucial to serve as inputs in policy making especially in times of the COVID-19 pandemic. The four All India surveys on migrant workers, domestic workers, employment generated by professionals and transport sector have tremendous role to play at national level by providing data on the most effected labour market participants. The Minister lauded the efforts of Shri Apurva Chandra, Secretary, L&E and Shri DPS Negi, Director General, Labour Bureau for their steadfastness and exemplary role which have finally culminated in the launch of four All India surveys.

INPUTS FROM PIB FIELD OFFICES

Kerala: The Centre has deputed yet another multi-disciplinary team to the state as it is witnessing a witnessing a surge in COVID-19 cases. The state has decided to exert more pressure on the Centre for additional vaccine stocks, as a chunk of the population still remains susceptible to Covid-19. Meanwhile, Kerala's cumulative burden of Covid cases rose to 10,40,903 with the state reporting 4,034 cases yesterday. The total death toll till date is 4,119. The first instance of local transmission of the mutant variant of Covid-19 was detected in Kerala on Tuesday. The state has reported 11 cases of the new strain so far. Immunisationprogramme for poll officials has begun in the state. As many as two lakh officers will get the first dose of the vaccine before March and the second dose before the ensuing assembly election.

- Tamil Nadu: As on date, Tamil Nadu recorded 8,49,166 total cases, 12,472 deaths, 442 Active cases and 8,32,620 discharges.
- Karnataka: State budget session will commence from March 4. The state government announced that marshals will be deployed at wedding halls and at events to ensure adherence to COVID protocols. A series of check posts were put across Maharashtra and Kerala borders to check COVID. Those entering Karnataka from these States must have RTPCR negative report. Upper primary classes reopened from Feb 22 and day one 42% attendance registered. Meanwhile state government has set a target of 80% to vaccinate health care workers in all districts by February end.
- Andhra Pradesh: As on date, Andhra Pradesh recorded 8,89,409 total cases, 7168 deaths, 575 active cases and 8,81,666 discharges. The recovery rate stands at 99.13 per cent. The state has conducted tests for 1,37,75,253 samples so far including 28,268 in the last twenty-four hours.Covid-19 vaccination drive was launched for the police personnel at AR Grounds in Vijayawada, yesterday. The vaccination drive for the police personnel will continue for 10 days. The vaccination programme to the police staff was postponed due to Panchayat polls held in the State in four phases. The first phase vaccine was given to the health workers and the second phase of vaccination is underway for the frontline workers.
- Telangana: A total of 1,11,829 health care workers have received the second dose of vaccine till now in the state. 1,95,850 Govt and Private health care workers received the first dose of vaccine. This is 59 percent of the total 3,31,097 health care workers targeted for Covid vaccination in the state. A total of 88,987 other frontline workers received the first dose till now. This is 35 percent of the total 2,57,239 frontline workers targeted for the vaccination. The second dose of vaccination for health care workers will be carried out on Wednesday (Today). A mop up session for first dose of vaccine for the left-out health care workers and other frontline workers will be carried out on 26th and 27th of this month. In the backdrop of number of Covid cases growing in neighbouring states like Maharashtra, Telangana Health Minister EetalaRajender held a review meeting with senior officials of his department on 22nd of this month to take stock of the situation. The Minister said the situation in the state is very much in control and there is no proposal to impose curfew and lockdown in any part of the state. He instructed the officials to ramp up RT-PCR tests.
- Maharashtra: Chief Minister Uddhav Thackeray reviewed the COVID situation in a meeting with Municipal Commissioners of MMR region. He also asked the Washim District Administration to take strict action against those who organised a large gathering at a religious place where the State Forest Minister offered worship. Home Minister Anil Deshmukh said that the sale of Coronil tablets of Patanjali will not be allowed in Maharashtra without proper certification from competent health organizations like WHO, IMA and others.In Marathwada region indefinite night curfew is being imposed in the district of Hingoli. Night curfew will begin at 7 pm every day and shall remain till next morning 7 am. In Jalna district, all schools, colleges, hostels, coaching classes and residential schools will remain closed till 31st March. A curfew has been imposed in Aurangabad. There will be a curfew from eleven o'clock at night to six o'clock in the morning. Dahiwadi village and the surrounding area in Satara district has been declared as a containment zone.







Active Cases decline in all States/UTs in the last month, No death reported in 18 States/UTs in last 24 hours, Recoveries continue to rise; Cumulative recoveries at 1.06 Cr, Nearly 90 lakh COVID19 vaccine doses administered

India's total Active Caseload currently stands at **1,36,549** today. The active caseload now consists of just **1.25%** of India's total Positive Cases. In a significant development, all States and UTs have reported a decline in active cases in the last month. Maharashtra has shown a substantial decline in active cases from 53,163 on 17 January, 2021 to 38,307 on 17 February, 2021. Eighteen States/UTs have not reported any COVID19 deaths in the last 24 hours. These are Uttar Pradesh, Rajasthan, Andhra

Pradesh, J&K (UT), Jharkhand, Puducherry, Himachal Pradesh, Lakshadweep, Manipur, Ladakh (UT), Assam, A&N Islands, Sikkim, Meghalaya, Tripura, Mizoram, Arunachal Pradesh and D&D & D&N. India's cumulative recoveries show a progressive increment on a daily basis. It stands at 1.06 Cr (1,06,44,858) today. The Recovery Rate is 97.33%. 11,833 patients have recovered and discharged in the last 24 hours. Rising recoveries combined with less new cases have ensured a decline in Active Caseload. 11,610 new daily cases have been recorded in the last 24 hours. As on 17thFebruary, 2021, till 8:00 AM, the cumulative vaccination coverage to healthcare and frontline workers against COVID19 in the country has reached nearly 90 lakhs. 89,99,230 vaccine doses have been given to beneficiaries through 1,91,373 sessions, as per the provisional report till 8 am today. These include 61,50,922 HCWs (1st dose), 2,76,377 HCWs (2nd dose) and 25,71,931 FLWs (1st dose). As on Day-32 of the vaccination drive (16th February, 2021), total **2,76,943 vaccine** doses were given across **7,001** sessions. Out of which, **1,60,691** beneficiaries were vaccinated for 1st dose and **1,16,252 HCWs** received 2nd dose of vaccine. 8 States account for 57.8% of the total vaccine doses administered in India. Uttar Pradesh alone accounts for 10.4% (9,34,962). As on 16th February, 2021, till 4 pm, total 36 cases of hospitalization and 29 cases of deaths have been reported from people who have been vaccinated. Out of the 36 cases of hospitalisation, 22 were discharged after treatment. 2 are still under treatment and 12 persons died. Out of the 29 deaths, 17 deaths are outside hospital whereas 12 deaths are in the hospital. 81.15% of the new recovered cases are observed to be concentrated in 6 States. Kerala has reported the maximum number of single day recoveries with 5,439 newly recovered cases. 2,700 people recovered in Maharashtra in the past 24 hours followed by 470 in Tamil Nadu. 86.15% of the daily new cases are from 6 States. Kerala reports the highest daily new cases at 4,937. 100 fatalities have been recorded in the last 24 hours. Six States account for 81.00% of the daily deaths. Maharashtra saw the maximum casualties (39). Kerala follows with 18 daily deaths and Tamil Nadu reported 7 casualties.

<u>Cereals exports see a sharp jump in April – December, 2020, notwithstanding logistical challenges posed</u> by COVID19

India's exports of cereals – rice, wheat and coarse cereals witnessed an impressive rise during first three quarters of 2020-21 financial year. As per the data during April-December, 2020, the exports of cereals rose to Rs 49,832 crore from Rs 32,591 crore (4581 US\$ million) reported during the same period in the previous year. The exports of cereals witnessed a rise of 52.90% in Rupee term and 45.81% in US dollar term. The total share of value of cereal exports was 48.61% in Rupee term in the total export of Agricultural and Processed Food Products Exports Development Authority (APEDA) scheduled products. As per the data during April-December, 2020, the export of **Basmati Rice** was Rs 2,038 crore (2947 US\$ Million) against Rs. 20,926 crore (2936 US\$ Million) reported during same period in the previous year. The exports of this aromatic and long-grain rice witnessed a growth of 5.31% in Rupee term and 0.36 % Dollar terms. During April-December 2020 period, the export of **Wheat** rose to Rs 1,870 crore (252 US\$ Million) against was Rs. 336 crore (48 US\$ Million) reported during the same phase a year back.

Use of Homoeopathy medicines in Covid-19 treatment discussed in Parliament

The Supreme Court has upheld the advisory of Ministry of AYUSH in its judgement dated 15.12.2020 and permitted use of homoeopathy medicine as add on to standard care in COVID-19 treatment. This was clarified by ShriKirenRijiju, Minister of State (IC) of the Ministry of Youth Affairs and Sports and Additional Charge of Minister of State (IC) for the Ministry of AYUSH to the LokSabha on Friday. The Minister added that while Homoeopathy treatment is not to be given in standalone mode for COVID-19 treatment, the Ministry of AYUSH through an advisory issued in March 2020 and the 'Guidelines for AYUSH practitioners for COVID-19' allowed AYUSH interventions including homoeopathy as add on to standard care. He also informed the House that the Ministry of AYUSH has taken many steps with the help of AYUSH systems of Medicine including Homeopathy for COVID-19 related treatment, and cited the Ministry's advisory issued on 29.01.2020 on "how to protect oneself from COVID and how to stay healthy" (which received wide attention and was adopted by large sections of the population).

Impact of Covid-19 on Agriculture

During the lockdown, the agriculture sector had functioned smoothly. Government of India has taken all necessary measures to ensure smooth operation of agriculture related activities. Farming and allied activities were exempted from the lockdown. Seed, pesticide, fertilizer etc. dealers / shops and other input related activities were allowed to open / free for making inputs available to the farmers. Inter and intra state movement of farm machinery specially combine harvesters was facilitated. As a result of the various steps taken by the Department, both harvesting activities of the Rabi Crop and sowing activities of Summer Crop took place in a systematic manner. Agriculture and Allied Sectors registered a growth of 3.4% during 2020-21 even as the overall economic growth declined by -7.2% during the same period.

Distribution of foodgrains during lockdown

The total stock of foodgrains in the Central Pool as on 01.01.2021 was 529.59 lakh tons consisting of 342.90 lakh tons of wheat and 186.69 lakh tons of rice. Under NFSA, 2013, there are only two categaries (i) Antyoday Anna Yojana (AAY), (ii) Priority House Hold (PHH) viz. the foodgrains would be distributed as per allocations made under the NFSA.For migrants/stranded migrants, who are not covered under NFSA or State ration cards, allocations of foodgrains was done under AtmaNirbhar Bharat Package (ANBP) for free of cost distribution by the States during May, 2020 to June, 2020.Government of India also approved supply of foodgrains for those non-NFSA beneficiaries, who have State ration cards for distribution from April, 2020 to June, 2020, @ Rs 21.00 per kg for wheat and Rs 22.00 per kg for rice.

In a heartening new development, first time post Covid, Indian Railway's cumulative Freight Revenue has surged past last year's levels and stands at Rs. 98068.45 crore as compared to Rs. 97342.14 to Fy 20-21 in same corresponding.On a month to month basis as well, in first 12 days of February, Railways has overtaken last year's freight revenue figures by 5%.On a monthly basis, Railway freight revenue has surged Rs. 206 crore ahead in Feb 21 compared to corresponding period Feb last year.

· Maharashtra: 3,663 new cases of COVID-19 were reported in Maharashtra on Tuesday, taking the total number of affected people to 20,71,306. It was the seventh day in a row that the state has reported more than 3,000 Covid-19 cases, after the number of cases were steadily declining till the end of January 2021. Under such a circumstance, Mumbai Mayor KishoriPednekar has warned the people that the city may head towards another lockdown. She expressed displeasure about the careless behavior of the people who are not following Covid-19 guidelines, especially while travelling in the trains.Deputy Chief Minister AjitPawar had also underlined the need to follow Covid-19 guidelines and had also threatened to come out with harsh decisions amid sudden rise of Covid cases in the state. According to the state's public health department, 2,700 people were discharged on the same day. The total number of recoveries has reached 19,81,408 in the state. The number of fatalities increased by 39, taking the death toll to 51,591. The state currently has 37,125 active patients. Maharashtra's recovery rate stands at 95.66 per cent while the case fatality rate stands at 2.49 per cent. Maharashtra has conducted 1.53 crore Coronavirus tests so far and the positivity rate stands at 13.45 per cent. With 461 new cases, Mumbai's caseload has increased to 3,15,030. The city reported three deaths and 340 recoveries during the day. Also, more than four thousand six hundred healthcare workers were given the second dose of vaccine against Covid-19. The second round of vaccination drives for healthcare workers began in Maharashtra on February 15, 2021.

• Gujarat: In Gujarat, over 8 lakh beneficiaries have received the first dose of Covid vaccine so far. The drive to administer the second dose of the Covid-19 vaccine to health workers began on Feb 15, 2021 (Monday). State Immunization Officer Dr Nayan Jani said on Tuesday that 80 percent vaccination of the healthcare and frontline workers has been completed in the state so far. Nearly 5,200 persons were vaccinated for COVID-19 across the 355 booths in the state on Tuesday. Meanwhile, 263 new Covid 19 cases were reported in the state on Tuesday and 271 patients were discharged. According to state health department, state's recovery rate now stands at 97.7 per cent. This apart, Gujarat government has extended the night curfew imposed in four metro cities of Ahmedabad, Surat, Vadodara and Rajkot till the end of this month.

 \cdot Madhya Pradesh: The state reported 233 new COVID-19 cases, 221 recoveries and 3 deaths on Tuesday. With this, the total cases have gone up to 2,58,082 and total recoveries to 2,52,385 while the death toll stands at 3841. There are 1856 active cases at present. Maximum cases were reported from Indore (93), Bhopal(39), and Jabalpur (19) on Tuesday.

 \cdot Chattisgarh: The state reported 250 new COVID-19 cases, 24 recoveries and 5 deaths on Tuesday. With this, the total cases have gone up to 3,09,623 and total recoveries to 3,02,935, while the death toll stands at 3783. There are 2905 active cases at present. Maximum cases were reported from Durg

(63), Raipur(59), and Rajnandgaon (20) on Tuesday.

 \cdot Rajasthan: The state reported 90 new COVID-19 cases as on Tuesday. With this, the total cases have gone up to 3,19,065 and total recoveries to 3,15,027 while the death toll stands at 2781. Total samples collected is 61,11,693 as on Tuesday

 \cdot Goa: 48 new cases were reported in Goa on Tuesday, which takes the total number of cases to 54,323. The number of active COVID patients is 504. The recovery rate of the state is 97.63%. The second phase of the vaccination drive began on February 9. In this phase, frontline workers, that is, the police force, home guards, revenue personnel, officials from municipalities & panchayats are to receive their first shot of the vaccine.

 \cdot Assam: In Assam, total COVID-19 cases rise to 2,17,309 with 5 new cases detected on Tuesday. A total of 14 patients also discharged yesterday. Total discharged patients 2,14,615 and 1089 total death. Active cases 258.

 \cdot Nagaland: In Nagaland, 1 new COVID-19 case was detected on Tuesday. Total cases rise to 12190 and active cases 41.

 \cdot Sikkim: In Sikkim, 3 people tested positive for COVID-19 and 1 recovered on Tuesday. Total cases rise to 6121, total discharged 5834 and 56 active cases.

• Kerala: The genome sequencing conducted by the Institute of Genomics and Integrative Biology has found out that thirteen Coronavirus variants that have undergone mutations capable of evading the body's immune system have been detected in Kerala. Of this, the variant 'N440K' calls for more caution. The Election Commission of India, headed by Chief Election Commissioner Shri. Sunil Arora which recently visited the state to review the preparedness for the upcoming assembly polls said, in view of the COVID-19 pandemic, the number of polling booths would be increased to 40,771 from the existing 25,000. The CEC also said that polling officials would be provided with Covid kits and administered with Covid vaccine on priority basis. The EC has expressed satisfaction over with the preparedness to tackle the pandemic. Meanwhile, the Covid-19 death toll has crossed 4,000 in the state. The test positivity rate stands at 6.64 percent. There are now 60,761 active Covid-19 cases in the state

 \cdot Tamil Nadu: As on date, Tamil Nadu recorded 8,46,026 total cases, 12,432 deaths, 4206 Active cases and 8,29,388 discharges.

 \cdot Karnataka: As on date, Karnataka recorded 9,46,6076 total cases, 12,273 deaths, 5860 Active cases and 9, 46,076 discharges. Karnataka has made it mandatory for passengers arriving from UK, Brazil and South Africa to produce RTPCR negative report before boarding flights. They also have to additionally undergo another test after landing and negative RT PCR report mandatory for those coming to state from Kerala.

 \cdot Andhra Pradesh: As on date, Andhra Pradesh recorded 8,88,959 total cases, 7163 deaths, 615 active cases and 881181 discharges

 \cdot Telangana: Administering of second dose of Covid vaccine to the health care workers who have already taken first dose has begun on 13th of this month in the state and till yesterday a total of 53,144 health care workers have received the second dose. The cumulative number of people including Govt, Private health care workers and frontline workers who have taken the first dose as on yesterday stands at 2,79,518. Number of Covid cases in the state (According to the Health Bulletin issued by the Director of state Public Health department today morning) reached 2,96,950 and the number of fatalities 1620. Number of recoveries stands at 2,93,690. Out of 1640 active cases in the state, 641 are in Home isolation.










Following a steady downward slope, India's Active Caseload down to 1.41 Lakh; Less than 5,000 Active Cases in 33 States/UTs;No Death in the last 24 hours in 19 States/UTs;More than 66 lakh beneficiaries vaccinated against COVID19

India has been consistently following a declining slope of active cases. The country's active caseload has dropped to **1.41 lakh (1,41,511)** today. The present active cases now consist of just **1.30%** of India's Total Positive Cases.Following the national cue, **33 States & UTs** have reported **less than 5000 active cases** in the last 24 hours. Daman & Diu & Dadra & Nagar Haveli currently have 0 active cases.**11,067** new daily cases have been recorded in the last 24 hours whereas **13,087** patients have recovered and discharged in the last 24 hours. It has led to a net decline of **2,114** cases from the total Active caseload.Two States – Kerala and Maharashtra- account for 71% of the total Active Cases of the country.**Nineteen States/UTs have not reported any death in the last 24 hours**. India's cumulative recoveries stand at **1,05,61,608** today. The Recovery Rate is **97,27%**.As on 10thFebruary, 2021, till 8 AM, more than **66 lakh (66,11,561)** beneficiaries have received vaccination under the countrywide COVID19 vaccination exercise. The total cumulative vaccination coverage of 66,11,561 includes **56,10,134** healthcare workers and **10,01,427** frontline workers. **1,34,746** sessions have been conducted so far.The final figures for the vaccination coverage for Day 25 (9th Feb 2021) of the country wide exercise include **3,52,553 beneficiaries (HCWs – 1,28,032 and FLWs- 2,24,521)** across **7,990** sessions.The number of beneficiaries being vaccinated every day is following a consistent upward slope.**81.68%** of the new recovered cases are observed to be concentrated in 6 States.Kerala has reported the maximum number of **single day recoveries** with 6,475 newly recovered cases. 2,554 people recovered in Maharashtra in the past 24 hours. Study shows significant reduction of heavy metal pollution during COVID-19 pandemicin the Ganga water

Efforts to minimize industrial wastewater can substantially reduce heavy metal pollution in the Ganga water in a short time span of a few months, a study carried out during the COVID-19 pandemic has shown. The COVID-19 pandemic lockdown provided a team of scientists **from Indian Institute of Technology Kanpur** a rare opportunity to quantify the impact of restricted anthropogenic activities on the water chemistry resilience of large rivers. They analyzed the daily geochemical record of the Ganga River and showed that reduced industrial discharge during 51 days of mandated nationwide lockdown decreased the dissolved heavy metal concentrations by a minimum of 50%. In contrast, inputs from agricultural runoff and domestic sewage like nitrate and phosphate remained almost the same as these sources were not impacted by the nationwide confinement.

Steps taken by Government to ameliorate impact of COVID-19 pandemic on Indian economy

As per the Estimates of Gross Domestic Product (GDP) for the First Quarter (Q1) of 2020-21 released by the National Statistical Office (NSO), Ministry of Statistics & Program Implementation (MoSPI), the real GDP in India contracted by 23.9 per cent during the first quarter of 2020-21 (as against 5.2 per cent growth in Q1 of 2019-20). India's GDP growth rose to (-) 7.5 percent YoY in Q2 (as against 4.4 per cent growth in Q2 of 2019-20), a sharp rebound from the pandemic induced decline in Q1.

Security Measures for Asha Workers during COVID-19

Under the National Health Mission, ASHAs are envisaged to be community health volunteer and are entitled only to task/activity based incentives. In FY 2018-19 the Union Cabinet revised the amount of incentive for ASHAs from Rs 1000 to 2000 per month. In addition to routine and recurring incentives, many States/UTs have also introduced fixed monthly honorarium for ASHAs from their respective States/UTs budget. The Government of India has been taking various measures to empower and secure the working of ASHAs from time to time. Under the recently launched Pradhan Mantri Garib Kalyan Package, Insurance Scheme has been introduced for all health workers, including ASHAs. This insurance scheme provides an insurance cover of Rs. 50 Lakh in case of loss of life on account of COVID related duty.States/UTs have been asked to ensure provision of safety tools like masks and sanitizers for ASHAs.

- Assam: In Assam, total COVID-19 cases rise to 2,17,256 with 27 new cases on Tuesday, total discharged patients 2,14,490 and 1086 total death. Active cases 333.
- Nagaland: In Nagaland, 06 new COVID-19 cases detected on Tuesday. Total cases rise to 12116.
- Kerala: Indian Council of Medical Research has urged Kerala to be more vigilant in defence activities of Covid-19. ICMR's stern directive comes after half of Covid cases reported in the country are from Kerala. Of the 13,088 cases reported in the country yesterday, 6475 were from Kerala. There are currently 1,41,511 patients under treatment in the country. Of these, 64,390 are from Kerala. The central team had earlier assessed that the decrease in tests was the reason for the sharp rise in Covid transmission in Kerala. Following this, the central team directed the state to increase the number of tests and sought an explanation for the increase in test positivity. Meanwhile, the Covshield vaccine drive for health workers in the state will come to an end in two days. A total of 3.26 lakh health workers have taken vaccine so far out of the over 5 lakh registered.

Nadu: A total of 89 doctors have died due to COVID-19 in Tamil Nadu, according to data published by the Indian Medical Association. Tamil Nadu Health Department officials said that the government would launch COVID-19 vaccination for senior citizens after Centre gives its permission. State reported 469 cases on Tuesday. Seroprevalence data for Tamil Nadu indicates that 31.6% has contracted COVID-19 at some point in time. 1,74,749 persons have got shots so far.

Karnataka: As on date, Karnataka recorded 9,43,212 total cases, 12,241 deaths, 5785 Active cases and 9,25,167 discharges. In a major decision Karnataka state government lifted ban on religious festivals, jatra and other celebrations. Religious Endowment department issued order and revoked March 20,2020 order which banned all types of religious festivities because of COVID-19. 4.41 lakh beneficiaries vaccinated.

- Andhra Pradesh: Polling for the first phase of panchayat elections passed off peacefully on Tuesday. The first phase of polling for 2,723 panchayats in Andhra Pradesh ended peacefully with 81.78 per cent turnout. Krishna district recorded the highest percentage of 85.06, according to the State Election Commission. The polls will be conducted till February 21 in another three phases. Elections were held with all necessary precautions taken as per COVID-19 protocol amid tight security and PPE kits were provided to voters infected by the virus. The State government constituted a high-level committee to monitor the implementation of the recommendations made by the Multi-disciplinary Committee on the mystery illness accompanied by sudden convulsions in Eluru Municipal Corporation limits of West Godavari district. Meanwhile, Andhra Pradesh witnessed 70 COVID-19 cases and no deaths in the last 24 hours ending Tuesday morning. The new cases took the tally to 8,88,555. The toll remains at 7,160 and the number of recoveries increased to 8,80,478 with 115 new recoveries in the past day. The recovery rate was 99.09 per cent. Less than 100 new cases a day were reported for the past week.
- Telangana: Covid vaccination programme for frontline warriors like Police, Revenue, Municipal, Panchayat Raj and personnel of the Central Para Military Forces started on 6th of this month in the state. State DGP Shri Mahender Reddy took the vaccine on the first day. The Director of State Public Health Dr.G.Sreenivasa Rao and the Central Reserve Police Force (CRPF) Southern Zone IG Shri Mahesh Ladda were also vaccinated on 8th of this month. The cumulative number of total vaccine beneficiaries (till yesterday evening) including govt, private health workers and other frontline warriors stands at 2,43,483. The vaccination for the frontline workers will continue till 12 of this month. From 13th onwards second dose will be administered to the health staff who have already taken the first dose. The total number of Covid cases reported in the state stands at 2,95,988 and the total number of fatalities at 1613. As many as 2,92,578 patients (98.84 percent) have recovered. Total number of active cases is 1,797 out of which 729 are in Home/Institutional isolation. A Sero survey conducted by the ICMR-National Institute of Nutrition (NIN), Hyderabad in the month of December last in the districts of JANGAON, NALGONDA and KAMAREDDY in the state revealed that the anti-bodies against Covid were found in 24 percent of the people indicating that these people had silent and prior exposure to SARS-CoV-2.
- Maharashtra: 2,515 new cases of COVID-19 were reported in Maharashtra on Tuesday. There are 34,640 active cases and 19,61,525 COVID-19 patients have been discharged after full recovery in the state as per the latest report.35 COVID-19 deaths were also reported in the state on Tuesday. Recovery rate in the state is 95.74%, while the Case fatality rate is the state is 2.51%. More than 5 lakh health workers and frontline workers have been vaccinated against Coronavirus in the state till Tuesday. State Health Minister Rajesh Tope said, in the third phase, people above the age of 50 years and those under 50 with co-morbidities will be vaccinated. Currently, there are 652 Vaccination Centres in the state. About 40,000 to 45,000 health workers are being vaccinated every day in the state. So far, 10 lakh 54 thousand health workers have been registered on the CoWin portal, out of which 4,68,293 health workers have been vaccinated. While 5,47,000 frontline workers have been registered out of which 41,453 have been vaccinated till Tuesday.
- Gujarat: 234 new COVID-19 cases have been reported in Gujarat on Tuesday. Meanwhile, 2,57,473 cases have been recovered from the disease, out of which 353 patients have recovered on Tuesday. At present, total active cases in the state are 2040. Maximum 70 new cases have been reported from Vadodara, while Ahmedabad recorded 43 new cases. The recovery rate has reached 97.56 percent in the state. More than 56,000 persons have been vaccinated for COVID-19 on Tuesday through 974 vaccination centres across the state. Total 6 lakh 60 thousand 516 persons have received vaccine against COVID-19 in the state till Tuesday.
- Madhya Pradesh: The statereported 167 new COVID-19 cases, 219 recoveries and 2 deaths on Tuesday. With this, the total cases have gone up to 2,56,758 and total recoveries to 2,50,946 while the death toll stands at 3825. There are 1987 active cases at present. Maximum cases were reported from Bhopal(44), Indore(33) and Jabalpur (11) on Tuesday.
- Chattisgarh: The state reported 206 new COVID-19 cases, 22 recoveries and 1 death on Tuesday. With this, the total cases have gone up to 3,07,996 and total recoveries to 3,00,078, while the death toll stands at 3746. There are 4172 active cases at present. Maximum cases were reported from Raipur(59), Durg(29) and Raigarh (25) on Tuesday.
- Rajasthan: The state reported 90 new COVID-19 cases as on Tuesday. With this, the total cases have gone up to 3,18,384 and total recoveries to 3,14,175 while the death toll stands at 2774. Total samples collected is 59,92,501 as on Tuesday
- Goa 59 new COVID-19 cases have been reported in Goa on Tuesday. There are 692 active cases and 52,530 COVID-19 patients have been discharged after full recovery in the state till Tuesday. The recovery rate of the state is 97.28%


