INDIA SITUATION

- As of 2 November 2021, India reported a total of 34,296,237 confirmed cases. In the past 24 hours, 10,423 confirmed cases have been reported, which is the lowest single day cases after second wave. Top five states, namely, Maharashtra, Kerala, Karnataka, Tamil Nadu, and Andhra Pradesh are contributing 56% of total cases

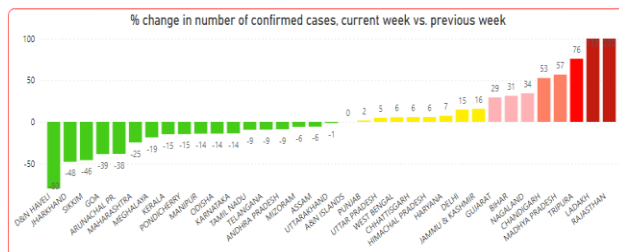

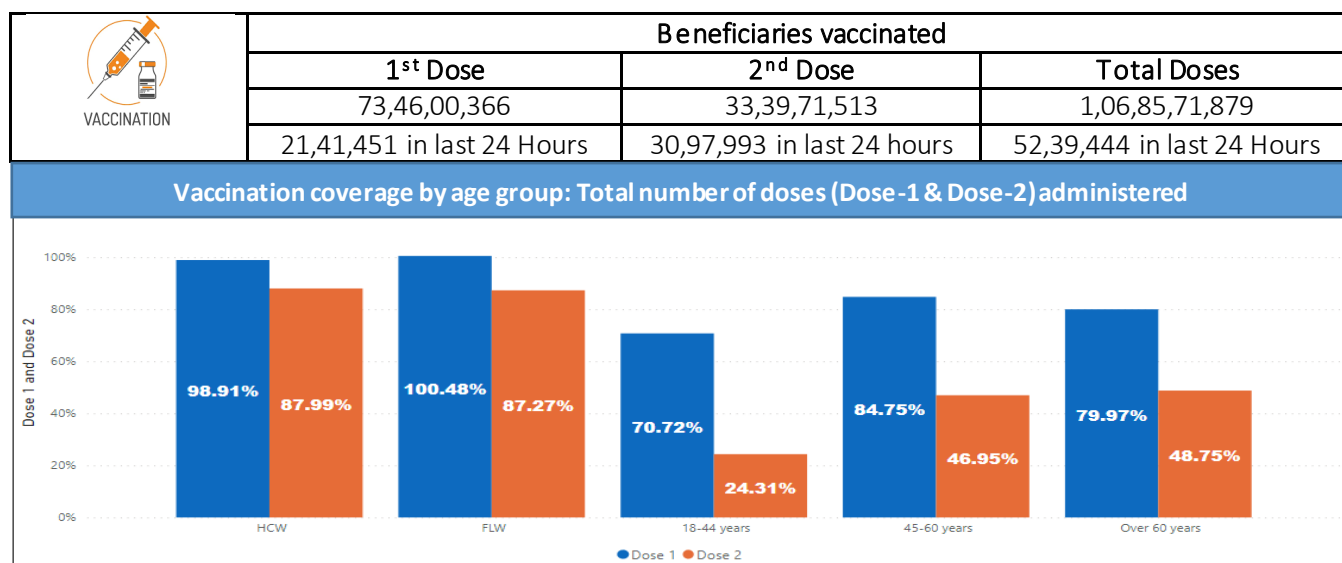

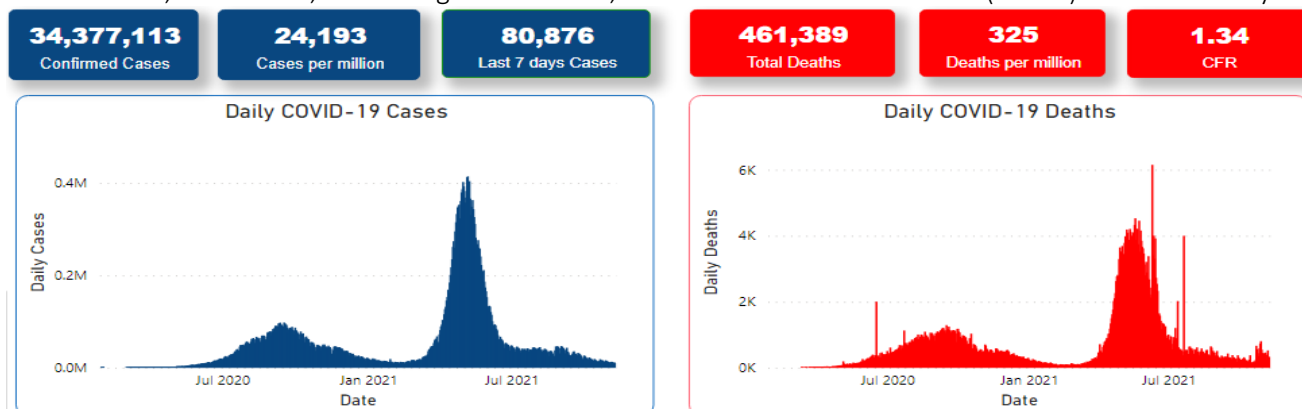

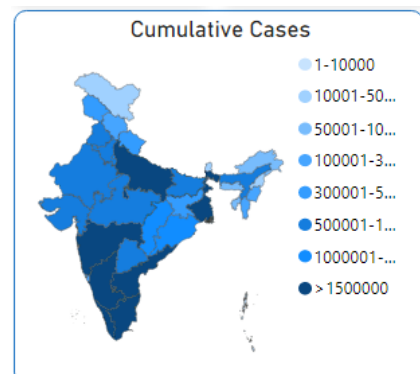

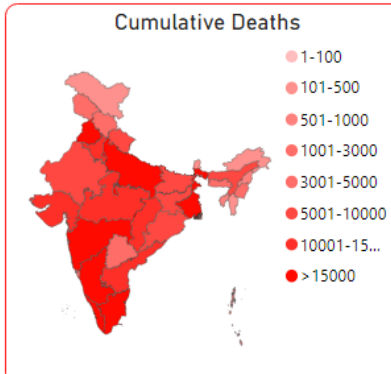


COVID-19: STATUS ACROSS STATES

- In the last week (3- 9 November), as compared to previous week (27 October- 2 November), 6 States/UTs have recorded a rise in the number new cases and 12 States/UTs have reported an increase in the number of deaths.

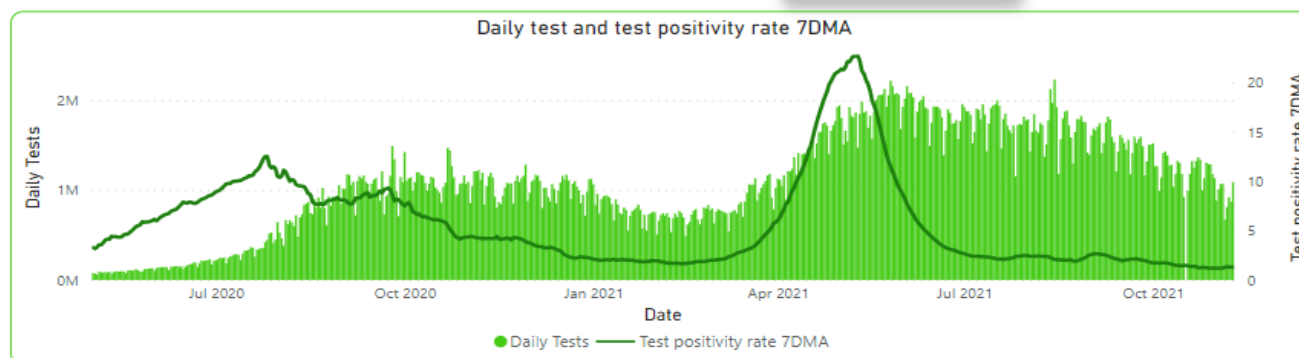

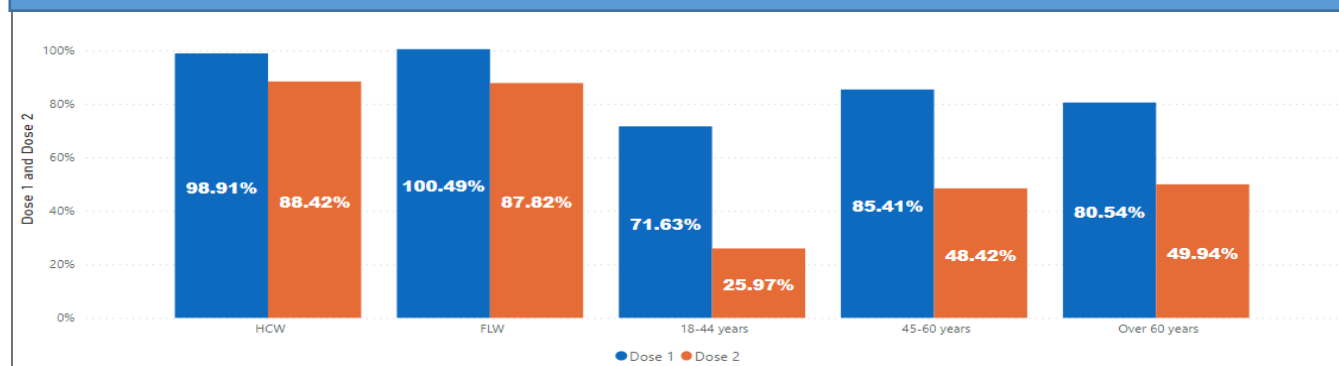

INDIA SITUATION

- In India, Maharashtra is still leading with highest number of cases (more than six million); Kerala has reported more than five million cases, followed by Karnataka, Tamil Nadu and Andhra Pradesh (more than two million cases each).
- Top five states, namely, Maharashtra, Kerala, Karnataka, Tamil Nadu, and Andhra Pradesh are contributing 57% of total cases. During last seven days 79,288 cases reported in country with Kerala reporting highest number of cases (44,710, 56% of total cases) followed by Maharashtra (6,639) and West Bengal (5,884).
- Apart from 220 districts, all districts have reported one or more than one COVID-19 case during last seven days
- In comparison to previous week (3-9 November), less than 35% of districts have shown increase in new cases during last week (10-16 November). Further, amongst the top 10 districts (Aizawal West, Greater Mumbai, Kolkata, Pune, Bengaluru Urban, 24- North Pargana, Thane, Khurda, Chennai & Coimbatore) reporting highest no. of cases during last week, eight (except Aizawal West & Khurda) have shown increase in no. of cases
- In the past week (10-16 November), India has reported 2,463 deaths, of which the highest were in Kerala (1,899) followed by Maharashtra (199) and West Bengal (79).

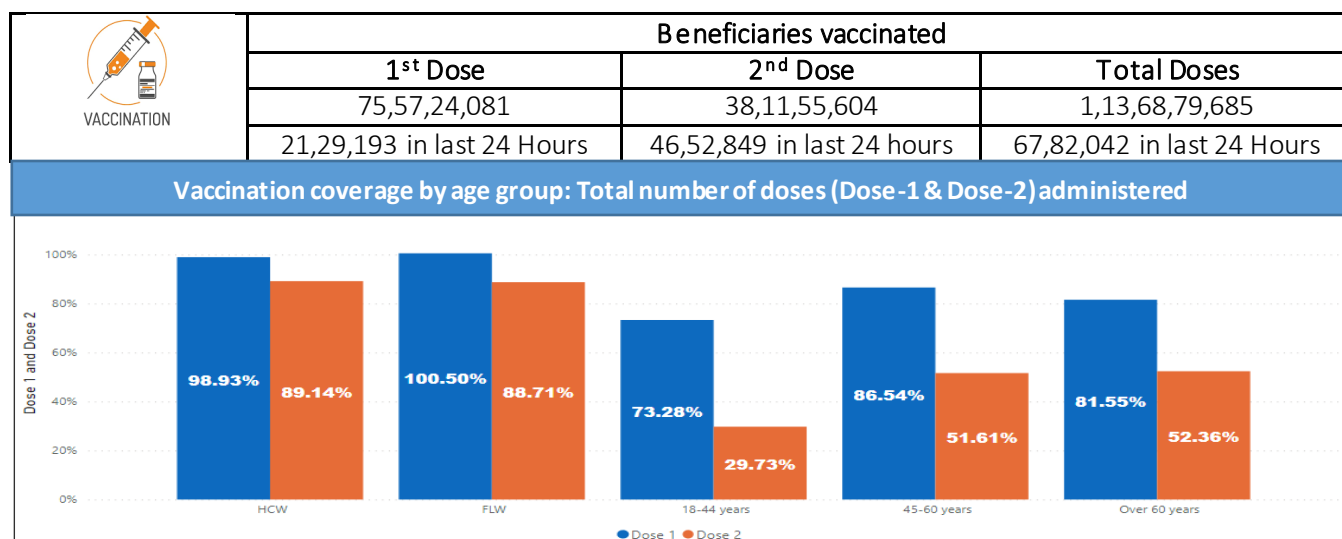

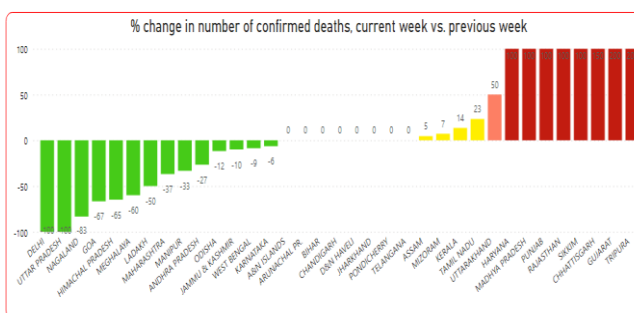
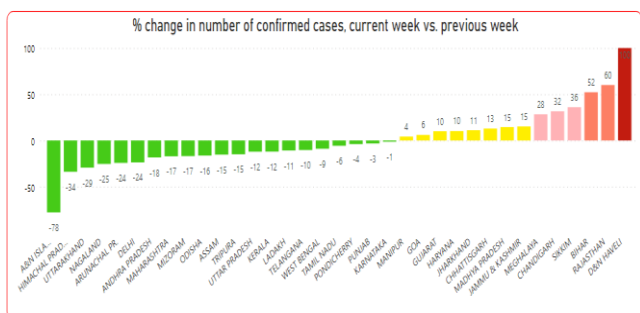
INDIA SITUATION

- As of 23 November, India reported a total of 34,526,480 confirmed cases. In the past 24 hours, 7,579 confirmed cases have been reported, this is the lowest single day cases after second wave. Currently, India reports 49 cases per million per week (7DMA: 17-24 November).



COVID-19: STATUS ACROSS STATES

- Maharashtra is still leading with highest number of cases (more than six million); followed by Kerala more than five million cases, and Karnataka, Tamil Nadu and Andhra Pradesh (more than two million cases each). States with more than one million cases reported are Uttar Pradesh, West Bengal, Delhi, Odisha and Chhattisgarh.
- Top five states, namely, Maharashtra, Kerala, Karnataka, Tamil Nadu, and Andhra Pradesh contribute 57% of total cases. During last seven days 70,079 cases were reported in the country with Kerala reporting highest number of cases (39,083, 56% of total cases) followed by Maharashtra (5,545) and West Bengal (5,485)
- In the last week (17- 23 November), as compared to previous week (10-16 November), 14 States/ UTs have recorded a rise in the number new cases and 13 States/UTs have reported slight increase in the number of deaths; however, the absolute numbers are very less.
- On warning level indicators of cases per million per week, % change in weekly cases and test positivity rate (7DMA), there are 36 districts in different states with warning level-4.

- WHO's COVID-19 Technology Access Pool (C-TAP) and the Medicines Patent Pool (MPP) has finalized a licensing agreement with the Spanish National Research Council (CSIC) for a COVID-19 serological antibody technology. The test effectively checks for the presence of anti-SARS-CoV-2 antibodies developed either in response to a COVID-19 infection or to a vaccine, details [here](#)

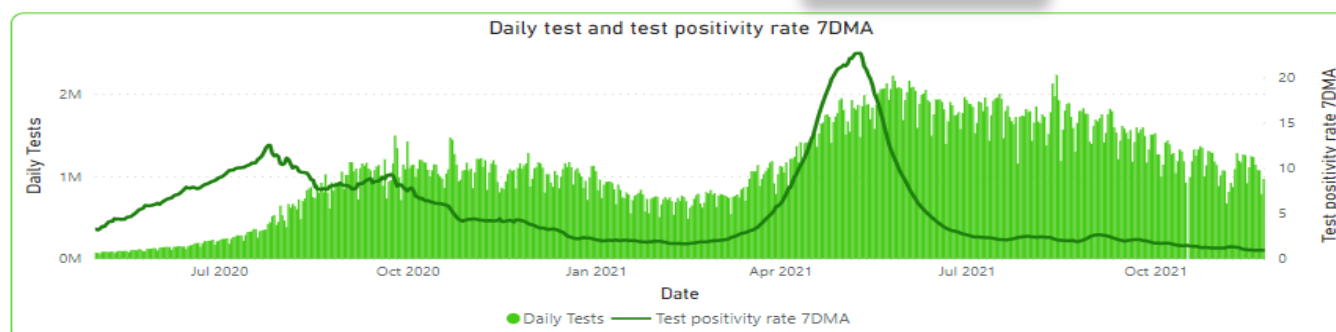
