INTRODUCTION

The Agriculture Censuses in India are being conducted quinquennially since 1970-71 as part of the World Census of Agriculture (WCA) of the Food and Agriculture Organization (FAO) of the U. N. The present Agriculture Census 2015-16 is the tenth in the series. The time series data generated through Agriculture Census provides valuable inputs for policymaking and tracks changes in the agriculture sector over the years. The basis statistical unit for data collection in Agriculture Census is "Operational Holding" rather than 'Ownership Holding' as the farm level decisions are taken by persons who operate the land and not by those who own it.

2. The Agriculture Census is conducted in three phases. In Phase-I, data are predominantly re-tabulated from the village land records. However, in States, where comprehensive land records are not maintained, data are collected through sample surveys and the results giving number and area of operational holdings at various administrative levels like Block/Tehsil, District and State are generated according to size classes, social groups, types of holdings and gender.

3. The present report has been prepared based on the data collected through Phase-I of Agriculture Census 2015-16. It provides key results on distribution of operational holdings at National level and for various States and UTs. After detailed scrutiny of the data at District/Tehsil level, this database has now been finalized and is being published in the form of an All India report on number and area of operational holdings.

4. I avail this opportunity to place on record my sincere thanks and appreciation to the field and supervisory staff of State/UT Governments for their effort and cooperation in completing the work of Agriculture Census. I would also wish to commend the excellent efforts of Dr. Dalip Singh, Deputy Director General & Agriculture Census Commissioner and his team in the Agriculture Census Division of this Department for continuously monitoring the census operations and providing technical and administrative support to the States/UTs.

OVERVIEW

Following standard international concepts, definitions and methodology recommended by FAO from time to time, the Agriculture Census in India is conducted by Department of Agriculture, Cooperation and Farmers Welfare, Ministry of Agriculture & Farmers Welfare, Government of India at five yearly intervals in collaboration with States/UTs.

2. Since the launch of first Agriculture Census in 1970-71, the country has conducted nine Agriculture Censuses so far and the present census with reference year 2015-16 is 10th in series. Entire Census operation is conducted in three phases and operational holding is taken as statistical unit at micro-level for data collection.
3. The provisional results for Phase-I released in September, 2018 have now been finalized and are being published in this report. The report is also available on this Department website: <http://agcensus.nic.in> for public use. Phase-I data of Agriculture Census is collected following Census-cum-Sample Survey approach. In States where comprehensive land records exist (Land Record States), data is collected and compiled through re-tabulation of information available in the Village Land Records. For other States (Non-Land record States), the data is collected on sample basis following household enquiry method.
4. As per the final results, the total number of operational holdings in the country has increased from 138.34 million in 2010-11 to 146.45 million in 2015-16 showing an increase of 5.8 per cent. The operated area has decreased to 157.82 million ha. in 2015-16 from 159.59 million ha. in 2010-11, a decline of 1.11 percent. The average size of operational holding has been steadily declining in the country over the years. The average operated size of holding which was 1.15 ha. in 2010-11 has declined to 1.08 ha. in 2015-16 at All India level.
5. I would like to place on record my appreciation of the contribution made by a large number of field functionaries of State/UT Governments without whose efforts this mammoth exercise would not have been completed. I would also like to commend the efforts of officers and staff of the Agriculture Census Division in this Department who worked sincerely and tirelessly to monitor Census operations and provided administrative and technical support to the States/UTs.

HIGHLIGHTS

This report is based on data collected on number and area of operational holdings for different size classes/social groups and gender during Phase-I of Agriculture Census 2015-16.

- The total number of operational holdings in the country has increased from 138.35 million in 2010-11 to 146.45 million in 2015-16 showing an increase of 5.86%.
- The total operated area in the country has decreased from 159.59 million ha. in 2010-11 to 157.82 million ha. in 2015-16 showing a decrease of 1.11%.
- In a total of 146.45 million operational holdings in the country, the highest number of operational holders belonged to Uttar Pradesh (23.82 million) followed by Bihar (16.41 million), Maharashtra (15.29 million), Madhya Pradesh (10.00 million), Karnataka (8.68 million), Andhra Pradesh (8.52 million), Tamil Nadu (7.94 million), Rajasthan (7.66 million), Kerala (7.58 million) etc. As regards operated area, out of a total of 157.82 million ha., the highest operated area was contributed by Rajasthan (20.87 million ha), followed by Maharashtra (20.51 million ha.), Uttar Pradesh (17.45 million ha.), Madhya Pradesh (15.67 million ha.), Karnataka (11.81 million ha.) etc.
- The percentage increase in number of operational holdings in 2015-16 as compared to Agriculture Census 2010-11 worked out to 5.86%. Among states, the highest increase in holdings was observed in the case of Madhya Pradesh (12.74%) followed by Andhra Pradesh (11.85%), Maharashtra (11.58%), Rajasthan (11.12%), Kerala (11.02%), Meghalaya (10.90%), Karnataka (10.83%) and Nagaland (10.16%) etc.
- 14 out of 36 States/UTs in the country accounted for about 91.01% of the total number of operational holdings and about 88.19% of the total area operated in the country. These States were Andhra Pradesh, Bihar, Chhattisgarh, Gujarat, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Odisha, Rajasthan, Tamilnadu, Telangana, Uttar Pradesh and West Bengal.

- The average size of operational holding has declined to 1.08 ha. in 2015-16 as compared to 1.15 in 2010-11.
- The percentage share of female operational holders has increased from 12.79% in 2010-11 to 13.96% in 2015-16 with the corresponding figures of 10.36% and 11.72% in the operated area. This shows that more and more females are participating in the management and operation of agricultural lands.
- The small and marginal holdings taken together (0.00-2.00 ha.) constituted 86.08% of the total holdings in 2015-16 against 85.01% in 2010-11 while their share in the operated area stood at 46.94% in the current census as against 44.58% in 2010-11.
- The Semi-medium and Medium operational holdings (2.00-10.00 ha.) in 2015-16 were only 13.35% with 43.99% operated area. The corresponding figures for 2010-11 census were 14.29% and 44.82%.
- The large holdings (10.00 ha. & above) were merely 0.57% of total number of holdings in 2015-16 and had a share of 9.07% in the operated area as against 0.70% and 10.59% respectively for 2010-11 census.
- A set of tables giving all India distribution of number of operational holdings and area operated and the state-wise breakup of distribution of the number of operational holdings and area operated by major size groups is presented in the tables that follow.

INTRODUCTION

1.1 Background

The Agriculture Census in India is conducted at five yearly intervals to collect data on structural aspects of operational holdings in the country. The Agriculture Census programme is carried out in three phases at five yearly intervals with cooperation of States/UTs. The Government of India provides financial and administrative support as well as all technical guidance to States/UTs required for Census operations. In each State/UT a nucleus staff of the State Government, designated as State Agriculture Census Unit is responsible for coordinating the activities of Agriculture Census Programme at the State/UT level.

The reference period for Agriculture Census is the Agricultural year (July-June). The first comprehensive Agriculture Census in the country was conducted with reference year 1970-71. So far, nine Agriculture Censuses have been conducted in the country. The current Agriculture Census with reference year 2015-16 is tenth in the series. Being the ultimate unit for taking agriculture-related decisions, operational holding has been taken as statistical unit at micro-level for data collection.

During Phase-I of the Agriculture Census, data on primary characteristics like number of operational holdings and area operated by different size classes (marginal, small, semi-medium, medium and large), social groups (SC, ST, Others), gender (male/female), types of holding (individual, joint and institutional), is collected. This operation covers all villages in land record States and 20 per cent of the villages in non-land record States.

During Phase-II of the Census, holding schedule is canvassed in selected 20 percent villages in each tehsil for collecting detailed data on characteristics of operational holdings such as land use, irrigation status, tenancy particulars, cropping pattern etc. Phase – III of the Census, popularly known as Input Survey, relates to collection of data on the pattern of input use by operational holdings. This survey is conducted in 7 percent of villages selected in each tehsil of the State/UTs.

The provisional results for first Phase of the current Census were released at State and all India level in September, 2018. After scrutinizing the results at District/Tehsil level, this database has now been finalized and is being published in the form of an All India Report on number and area of operational holdings.

1.2 Objectives

The main objectives of Agriculture Census are:

- To describe structure and characteristics of agriculture by providing statistical data on operational holdings, including land utilization, irrigation, irrigated and unirrigated area under different crops, use of agricultural machinery and implements, use of fertilizers, seeds, agricultural credit etc.
- To provide benchmark data for formulating new agricultural development programmes and for evaluating their progress.
- To provide basic frame of operational holdings for carrying out future agricultural surveys and,
- To lay a basis for developing an integrated programme for current agricultural statistics.

1.3 Agriculture Census Methodology

The Agriculture Census data is collected following two broad approaches; in States where comprehensive land records exist (Land Record States), for Phase-I of the Census, the data on primary characteristics of operational holdings are collected and compiled on complete enumeration basis through re-tabulation of information available in the Village Land Records.

For other States (Non-Land record States), this data is collected through sample survey in 20 per cent of villages in each block. These villages are selected through simple random sampling method and all the operational holdings in the selected villages are enumerated following household enquiry approach. The sample villages are same as those selected for the scheme Establishment of an Agency for Reporting of Agricultural Statistics (EARAS) for the reference year of the Census.

The States where data collected through household enquiry approach include, viz. Kerala, Meghalaya, Manipur, Nagaland, Odisha, Tripura, Sikkim, West Bengal, Arunachal Pradesh, Goa, Mizoram, Punjab and a few Districts of the State of Assam. In smaller UTs, like Lakshadweep, Daman & Diu etc., no sampling is done. i.e. all holdings in all the villages are surveyed for collection of data.

During Phase-I Agriculture Census 2015-16, the computerized data of ownership holdings were also utilized for data collection in a few States. In such States, the ownership data was retrieved from the computerized land records and latter converted to operational holdings after verification by the field functionaries.

CONCEPTS & DEFINITIONS

2.1 Coverage

The Agriculture Census 2015-16 was conducted in all the States/UTs with Agriculture Year as a reference period for collecting the data.

2.2 Definitions

Operational Holding:

All land which is used wholly or partly for agricultural production and is operated as one technical unit by one person alone or with others without regard to the title, legal form, size or location.

Technical Unit:

An unit of land which is under the same management and has the same means of production such as labour force, machinery and animals.

Operated area:

Operated area includes both cultivated and uncultivated area, provided part of it is put to agricultural production during the reference period. If, for instance, an operational holding consists of four survey numbers out of which one survey number is put to non-agricultural uses, the total area of the operational holding will be equal to the total geographical area of all the four survey numbers.

Operational holder:

A person who has the responsibility for the operation of the agricultural holding and who exercises the technical initiative and is responsible for its operation. He may have full economic responsibility or may share it with others. The operational holder may be Individual/Joint/ Institutional.

Individual: If the holding is being operated either by one person or by a group of persons who are the members of the same household, such holding will be considered as an individual holding.

Joint: If two or more persons belonging to different households, share jointly as partners in the economic and technical responsibility for the operation of an agricultural holding, such holding will be considered as joint holding.

Institutional: Holdings such as government farms, farms of sugarcane factories, cooperative farms, lands managed by trusts would be treated as institutional holdings.

2.3 Size classes and Size groups of Holdings:

The data are presented at All India level and for all States and Union Territories in the following size classes and size groups of operational holdings








Percentage share of different social groups in number of operational holdings as per Agriculture Census 2015-16



Percentage share of different social groups in area operated by holdings as per Agriculture Census 2015-16








